I. Objectives

This survey was designed to achieve the following objectives:

- Assist the World Bank in gaining a better understanding of how stakeholders in South Africa perceive the Bank;
- Obtain systematic feedback from stakeholders in South Africa regarding:
 - > Their views regarding the general environment in South Africa;
 - > Their overall attitudes toward the World Bank in South Africa;
 - Overall impressions of the World Bank's effectiveness and results, knowledge and research, and communication and information sharing in South Africa; and
 - > Perceptions of the World Bank's future role in South Africa.
- Use data to help inform the South Africa country team's strategy.

II. Methodology

In June and August 2012, 481 stakeholders of the World Bank in South Africa were invited to provide their opinions on the Bank's assistance to the country by participating in a country survey. Participants in the survey were drawn from among the office of the President; the office of a Minister; the office of a Parliamentarian; employees of a ministry, ministerial department, or implementation agency; consultants/contractors working on World Bank-supported projects/programs; project management units (PMUs) overseeing implementation of a project; local government officials or staff; bilateral agencies; multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs; community-based organizations (CBOs); the media; independent government institutions; trade unions; faith-based groups; academia/research institutes/think tanks; and the judiciary branch. A total of 69 stakeholders participated in the country survey (14%).

Respondents received questionnaires via post or email and returned it accordingly, or completed questionnaires with a representative of the fielding agency. Respondents were asked about: general issues facing South Africa, their overall attitudes toward the Bank; the World Bank's effectiveness and results; the Bank's knowledge; working with the World Bank; the Bank's future role in South Africa, and the Bank's communication and information sharing.

Every country that engages in the Country Survey must include specific indicator questions that will be aggregated for the Bank's annual Corporate Scorecard. These questions are identified throughout the survey report.

II. Methodology (continued)


- A. <u>General Issues facing South Africa</u>: Respondents were asked to indicate their three most important development priorities in South Africa.
- B. <u>Overall Attitudes toward the World Bank</u>: Respondents were asked to rate their familiarity with the World Bank, the Bank's effectiveness in South Africa, Bank staff preparedness, the extent to which the Bank should seek to influence the global development agenda, agreement with various statements regarding the Bank's work, and the extent to which the Bank is an effective development partner. Respondents were also asked to indicate the sectoral areas on which it would be most productive for the Bank to focus its resources, the Bank's greatest values and greatest weaknesses in its work, with which groups the Bank should collaborate with more in South Africa, and how they attribute slow or failed reform efforts.
- C. <u>World Bank Effectiveness and Results</u>: Respondents were asked to rate the extent to which the Bank's work helps achieve sustainable development results in South Africa, the Bank's level of effectiveness across thirty-four development areas, such as economic growth and basic education, the extent to which the Bank meets South Africa's need for knowledge services and financial instruments, and their level of agreement with a series of statements regarding working with the Bank, such as the World Bank's "Safeguard Policy" requirements being reasonable.
- D. <u>The World Bank's Knowledge</u>: Respondents were asked to indicate how frequently they consult Bank knowledge products and research and to rate the effectiveness and quality of the Bank's knowledge products and research, including how significant a contribution it makes to development results and its technical quality.
- E. <u>The Future Role of the World Bank in South Africa</u>: Respondents were asked to rate how significant a role the Bank should play in South Africa in the near future, their level of agreement with a series of statements regarding Eskom, and to indicate what the Bank should do to make itself of greater value in South Africa.
- F. <u>Communication and Information Sharing</u>: Respondents were asked to indicate where they get information about economic and social development issues, how they prefer to receive information from the Bank, their access to the Internet, and their usage and evaluation of the Bank's website. Respondents were asked about their awareness of the Bank's Access to Information policy, past information requests from the Bank, and their level of agreement that they use more data from the World Bank as a result of the Bank's Open Data policy. Respondents were also asked to indicate their level of agreement that they know how to find information from the Bank and that the Bank is responsive to information requests.
- G. <u>Background Information</u>: Respondents were asked to indicate their current position, specialization, whether they professionally collaborate with the World Bank, their exposure to the Bank in South Africa, and their geographic location.


In addition, when possible, responses from respondents completing this year's country survey were compared to responses from the 54 respondents who completed the survey in FY 2006. Notations and/or charts are included when these comparisons were possible.

III. Demographics of the Sample

Current Position

• For further analyses, the small number of respondents from bilateral agencies were combined with those from multilateral agencies, respondents from private foundations and faith-based groups were combined with those from NGOs, respondents from the financial sector/private banks were combined with those from the private sector, and the few respondents from the media were included in the "Other" category.






Area of Primary Specialization


Geographic Location


Because of the small number of respondents from areas other than Gauteng, it was not

Collaboration with and Exposure to the World Bank



Familiarity with the World Bank


- Across all respondents, familiarity with the Bank received a mean rating of 5.4; this was statistically similar to the mean rating received in the FY '06 country survey (5.9).
 - Respondents across all stakeholder groups had statistically similar levels of familiarity with the Bank.
 - It should be noted that respondents' ratings of familiarity with the Bank were significantly, moderately correlated with their perceptions of the Bank's overall effectiveness in South Africa, and had small, but significant correlations with the Bank's ability to help achieve sustainable development results and the Bank's relevance to South Africa's development.



IV. General Issues facing South Africa

Development Priorities

- Half of all respondents in the FY '06 country survey indicated that increasing employment was the most important development priority (50%), followed by reducing poverty (30%), HIV/AIDS (23%), and improving government effectiveness (22%).
- Although respondents from most stakeholder groups indicated that basic education and job creation were the most important development priorities in South Africa, respondents from bilateral or multilateral agencies were more likely to indicate that HIV/AIDS, TB, and other communicable diseases were the most important priority.




Which ONE is the third most important priority?" (Respondents chose from a list.)

Focusing World Bank Resources


 Respondents in the FY '06 country survey indicated that it would be most productive for the Bank to focus most of its resources on education (28%) and job creation/employment (26%) in South Africa.




V. Overall Attitudes toward the World Bank (continued)

The World Bank's Overall Effectiveness in South Africa (Indicator Question)

- Ratings of the World Bank's work achieving sustainable development results in South Africa received a mean rating of 5.6 across all respondents.
- Across all respondents, ratings of the World Bank's overall effectiveness in South Africa received a mean rating of 5.3; this was statistically similar to the mean overall effectiveness rating received in the FY '06 country survey (5.1).
 - Respondents across all stakeholder groups had statistically similar ratings for the Bank's overall effectiveness in South Africa and for the World Bank's work achieving sustainable development results in South Africa.





Bank Staff are Well Prepared to Help South Africa


The World Bank's Greatest Value in South Africa


Specific Areas of Effectiveness (continued)

- There were significant stakeholder group differences in their ratings of the Bank's effectiveness in two of these thirty-four development areas.
 - Respondents from NGOs/private foundations/faith-based groups had the highest ratings for the Bank's effectiveness at anti-corruption whereas respondents from the private sector/financial sector/private banks had significantly lower ratings.
 - Employees of ministries/implementation agencies and respondents from local government had the highest ratings for the Bank's effectiveness at environmental sustainability whereas respondents from bilateral or multilateral agencies, NGOs/private foundations/faith-based groups, and other organizations had significantly lower ratings.

Specific Areas of Effectiveness (continued)

 Respondents in this year's country survey gave significantly higher ratings for the Bank's effectiveness in energy compared to respondents from the FY '06 country survey. All other areas that could be compared had statistically similar ratings across both country surveys.


Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the Bank's overall effectiveness and ratings of its ability to help achieve sustainable development results in South Africa, bivariate correlational analyses were conducted using respondents' ratings of the thirty-four specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the Bank's overall effectiveness or ratings of its ability to help achieve sustainable development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the Bank's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the Bank's ability to help achieve sustainable development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the Bank's overall effectiveness or perceptions of the Bank's ability to help achieve sustainable development results.

- <u>Overall Effectiveness</u>: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's overall effectiveness in South Africa. The areas determined to be key drivers from these analyses were:
 - > The Bank's effectiveness at crime and violence;
 - > The Bank's effectiveness at agriculture and rural development; and
 - > The Bank's effectiveness at energy.
 - Of note, the areas determined to be key drivers of the Bank's overall effectiveness in the FY '06 country survey were:
 - The Bank's effectiveness in helping to strengthen the social protection sector;
 - The Bank's effectiveness in helping to reduce poverty; and
 - The Bank's effectiveness in helping to bring about economic growth.
- <u>Achieving Sustainable Development Results:</u> Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's ability to help achieve sustainable development results in South Africa, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's ability to help achieve sustainable development results. The area determined to be the key driver from these analyses was:
 - > The Bank's effectiveness at economic growth.



Knowledge: Frequency of Use


Knowledge: Meeting South Africa's Knowledge Needs (Indicator Question)

 Respondents across all stakeholder groups had statistically similar levels of agreement that the Bank meets South Africa's needs for knowledge services.




Knowledge: Focusing Bank Research



Knowledge: Effectiveness




Knowledge: Qualities


Knowledge: Contribution (Indicator Question)

 Respondents across all stakeholder groups had statistically similar ratings for the significance of the contribution that the World Bank's knowledge products and research make to development results in South Africa.




Knowledge: Technical Quality (Indicator Question)

 Respondents across all stakeholder groups had statistically similar ratings for the technical quality of the World Bank's knowledge products and research.




Knowledge: Providing Linkage to Non-Bank Expertise



Instruments: Meeting South Africa's Needs (Indicator Question)


 Respondents across all stakeholder groups had statistically similar levels of agreement that the World Bank's financial instruments meet South Africa's needs.


The World Bank's Work in South Africa




The World Bank as an Effective Development Partner






Collaborating in South Africa


- Employees of ministries/implementation agencies indicated that the Bank should collaborate more with local government and the development partner community.
- Respondents from local government indicated that the Bank should collaborate more with local government.
- Respondents from bilateral or multilateral agencies indicated that the Bank should collaborate more with NGOs and the private sector.
- Respondents from the private sector/financial sector/private banks indicated that the Bank should collaborate more with the private sector.
- Respondents from NGOs/private foundations/faith-based groups indicated that the Bank should collaborate more with NGOs.
- Respondents from academia/research institutes indicated that the Bank should collaborate more with academia/think tanks/research institutes.



Overall Evaluations of Eskom

- Employees of ministries/implementation agencies and respondents from the private sector/financial sector/private banks had the highest levels of agreement that the World Bank should be involved in infrastructure projects such as Eskom whereas respondents from bilateral or multilateral agencies had significantly lower levels of agreement.
- Respondents from bilateral or multilateral agencies had the highest levels of agreement that there is no value added from World Bank involvement in large infrastructure projects like Eskom whereas respondents from the private sector/financial sector/private banks had significantly lower levels of agreement.






Influencing the Global Development Agenda

Attributing Slow or Failed Reform Efforts


Respondents from most stakeholder groups indicated that slow or failed reform efforts should be attributed to poor coordination with development partners, the Government working inefficiently, an inadequate level of citizen/civil society participation, and inadequate capacity in Government; however, employees of ministries were more likely to attribute slow or failed reform efforts to the World Bank working slowly or the World Bank not being sensitive enough to political/social realities on the ground.

Information Sources


 Respondents in the FY '06 country survey indicated that they got most of their information about economic and social development issues in South Africa from local newspapers (54%) and reports/surveys (44%).


Preferred Information Sources





Internet Access


• All respondents indicated that they had access to the Internet (100%).

- Respondents from local government and the private sector/financial sector/private banks were significantly *less* likely to have used the Bank's website compared to respondents from other stakeholder groups.




 Respondents across both country surveys had statistically similar rates of usage for the Bank's country and main websites.


Website Evaluation
